

VEHICLE CONSENT FORM

NEW AND RETURNING STUDENTS: Please complete this form **ONLY** if this is your student's first year driving a vehicle to and from school.

The School reserves the right to grant driving privileges to our students. Families seeking driving privileges for their student must submit a vehicle consent form before the student is allowed to bring a vehicle on campus. Parents will be notified if consent is denied.

Students will be given a numbered parking cling tag and the number should be clearly visible from outside the vehicle. The new tag should be displayed on the inside lower right hand corner (drivers side) of the rear window.

PLEASE NOTE: Authorized school officials may search student vehicles at any time.

BOARDING STUDENTS: Boarding student vehicles are to be parked in the athletic area parking lot. All vehicles should be locked. Vehicles are only for travel to and from home on weekends and vacations. They may not be used for day trips without approval from the Assistant Head of School, the Director of Student Life, or the Director of Residential Life. Students who have returned to campus from a weekend away are considered "on campus" and may not leave without the permission of the Weekend Coordinator. Students failing to abide by the residential vehicle policies may be required to turn their keys into the Main Office and/or have their driving privileges revoked.

DAY STUDENTS: Day student vehicles are to be parked in their specified numbered space in the main campus parking lot. The following rules will apply to day student vehicles:

1. Vehicles are not to be driven around campus. Vehicles are to remain in the main parking lot until after the last commitment of the day. Only the Head of School or the Office of the Assistant Head of School for Student Life can grant an exception to this rule.
2. Students are to remove all items needed for the school day from their vehicles before morning meeting.
3. Day students are not allowed to return to their vehicles during the school day without permission from the Student Services Office.
4. Students are not to sit in vehicles or loiter in the parking area.
5. Vehicles cannot be used to transport other students to the athletic complex or off campus without permission from the Student Services Office.
6. Students may drive to practice if they do not drive on the lake road and must leave directly from the fields or lower campus to go home.

Failure to obey the stated rules may result in the loss of driving privileges for one week. A second offense after losing driving privileges for one week will result in the loss of driving privileges for the remainder of that semester. Speeding and reckless driving in the vicinity of the campus will result in the loss of driving privileges indefinitely.
